Dear Mr Fuglsang (m.p.),

Thank you very much for your letter in which you and a further 44 Members of the European Parliament point out the serious problems encountered in long-distance live animal transports to other EU Member States and third countries and emphasize the urgent need for action.

Ensuring animal welfare during transportation is of great importance to the Federal Government. Irrespective of the EU Council Presidency, Germany is pressing strongly for an improvement of the transport conditions. My Ministry has picked up on the

subject at different levels and called for progress, e.g. vis-à-vis the European

Commission, in the Council for Agriculture and Fisheries, within the EU Platform on

Animal Welfare, in negotiations on third country certificates and also in workshops

held at the World Organisation for Animal Health (OIE).

Together with other Member States we repeatedly turned to the European

Commission and demanded an amendment to the EU Regulation on the protection of

animals during transport, most recently in a joint letter drafted by the Member States

of Belgium, Denmark, the Netherlands, Sweden and Germany to the European

Commission of May 2019. In particular, the initiative aimed to limit the transport

duration and improve transport conditions.

The Council conclusions on the Farm to Fork Strategy of 19 October 2020, among

other things, welcome the announcement in the strategy to review existing animal

welfare law, including the fields of transport and slaughtering, on the basis of current

scientific findings. The objective is to make animal welfare law more comprehensive,

implement it in a better way and thus achieve a higher level of animal welfare. In this

context, the European Commission was called upon to revise the animal welfare rules

in force, in particular with respect to animal transports, as soon as possible.

I expressly welcome the fact that the European Commission and the Council

recognise the revision of the legal foundations as necessary. This fills me with

confidence that, together, we will find solutions, taking the needs of individual

Member States into account. It must be our aim to ensure animal transports in the

future that fulfil the European Union's animal welfare mandate. Germany will

continue to get involved to this effect, both during the Council Presidency and

thereafter as well.

letter.
